I waive any claim for negligence or for intentional acts of any kind for me, my dependents, beneficiaries, executors and assign and further release and waive any claim I might have against the officers, agents, members or employees of Station L Rowing Club.

I further agree to indemnify, defend, and hold harmless Station L Rowing Club, its officers, agents, members, employees and anyone else acting on the club's behalf from all claims, demands, causes of action, and suits arising out of any participation by me in any activity associated with Station L Rowing Club including, but not limited to all practices, classes, activities, regattas, and events.
